Neighbourhood Learning in Deprived Communities (NLDC)

Aims/priorities: The Lifelong Learning Service is inviting Expressions of Interest to work with us to deliver five partnership projects. The main purpose of the project is to provide opportunities for the most deprived communities in Oldham. This will include adults (19+) of different ages and backgrounds to gain a new skill, reconnect with learning, learn how to support their children better or prepare for progression to more formal courses or employment. We want the projects to focus on the following themes:

- English & maths
- Confidence & motivational skills

Green Dividend

Aims/priorities: The Green Dividend Fund is a fund to spark and support community action and initiatives. It aims to enable places in Oldham to be greener through innovative gardening, landscaping and other environmental projects. The fund aims to help deliver ideas and projects that make a real difference now, and in the future.



These projects benefit streets and neighbourhoods for both residents and visitors.

Who can apply? Voluntary, Community and Social Enterprise (VCSE) organisation including small local community and voluntary groups, registered charities and social enterprises and cooperatives. If you are a group of residents who are not a VCSE organisation you can still apply for funding, but you will require the support of a local councillor who will act as a sponsor. The Council will administer funds on your behalf.

Grant amount: Between £500 and £5000 for any project.

Our Rochdale Connect You

Aims/priorities: Applications must demonstrate how it will meet all 5 key criteria:



- Enabling – working with current or new community groups to quickly and easily support them
- Responding – to opportunities and gaps identified within communities
- Connecting – reaching and involving more community members as a result of the funding
- Targeting – specific groups such as, long term conditions, or areas agreed at neighbourhood level
- Building – adding value to your community through an essential 'trade' criteria where the receiving group are asked to offer a trade-off in a community contribution.

There are 5 priorities to bid against focused on fun, connecting people and ultimately improving lifestyles. These priorities have also been identified because they are centred on evidence based approaches which impact on the seed funding theme of improving wellbeing and reduce pressure on services:

- Arts and culture
- Walking and physical activity

- Growing and cooking
- Connect 5 / mental wellbeing
- Self-care / people supporting people around health conditions

Who can apply? The funding is for Rochdale Borough grassroots organisations, particularly emerging local groups as well as charities and other not-for-profit organisations whose focus is on local work (annual income under approx £100,000).

Aims/priorities: The GP practices within the Stalybridge Neighbourhood (Stalybridge, Mossley and Dukinfield) would like to work with the local community to invest in building the capacity of local groups and their activities. Aims/priorities: Near Neighbours brings people together from communities that are religiously and ethnically diverse, so that they can get to know

ARTS

The Arts Society

Aims/priorities: The Arts Society is a leading arts education charity with a global network of over 380 local Societies, which bring people together through a shared curiosity for the arts. All grants from The Arts Society are intended to give access to the arts to those that wouldn't normally have access to them. We believe in Arts for All and will use our grants to make a positive contribution to people's lives through the arts.



We have identified three areas of giving that are in accordance with our charitable objectives and meet specific needs in the arts & heritage sectors.

- Young Arts - Young Arts programmes support a wide range of activities to introduce young people to and engage them in artistic experience and practice. They include: artists in residence; art lectures for students; funding visits to art galleries and museums; art exhibitions for young artists; equipment purchases; practical workshops; local Arts Week events; bursaries for individual students; and sponsorship for craft apprentices.
- Skills Development - This area is about projects and programmes that further the development and training of skills in the arts, crafts and heritage. There are no age limits to this as we believe that people of all ages benefit from acquiring and honing their creative and heritage skills.
- Regional Museums, Galleries and Arts Organisations - The work of regional and local museums and galleries is important in connecting people with their local heritage and arts; yet these institutions often struggle to raise funds for projects and internships during times of budget cuts. Our grants may support special projects, displays, internship or part-time posts, training and conservation activities. We will also consider applications involving regional and local theatres and performing arts spaces and groups.

Who can apply? Registered UK Charities with a turnover of £3M or less and Member societies of The Arts Society

Grant Amount: Last round was up to £3000. Next round opens at end of July 2019.

Andrew Lloyd Webber Foundation

Aims/priorities:

The Andrew Lloyd Webber Foundation's principle objectives are to promote the arts, culture and heritage for the public benefit. Funding is available to not-for-profit organisations, including charities, companies and community trusts, for projects in the areas of culture and the arts that make a real and ongoing difference to people's lives in the UK. Priority will be given to projects that enable people to develop skills and careers in heritage and in all areas of the performing arts (music, dance and drama) but other areas will be considered.



For the purposes of funding:

- **Real** means an appreciable and significant difference. For example, something that affects one person's life to a great extent, possibly leading to a significantly improved probability that the person will be involved in the Arts on an ongoing basis (ie, by having a career in the Arts) and something that affects many people's lives, (ie, through improved access to the Arts).
- **Difference** implies that the funding award contributes to something that would not otherwise happen, without the making of such awards. This might (but need not necessarily) include the overcoming of special difficulties/obstacles.
- **Ongoing** refers to something that is going to have a long-term benefit and an ongoing effect on people's lives, rather than 'an effect that is ephemeral'.

Who can apply? Not-for-profit organisations, including charities, companies and community trusts, based and operating within the UK, are eligible to apply.

Grant amount: Unlock grants up to £5,000, Enhance grants up to £10,000, Empower grants up to £25,000. It is expected that most applicants would have secured a significant proportion of funding prior to sending in their application.

Application process: Two stage process. Apply online by completing a short application form outlining your project. We automatically acknowledge by email and decide whether to take it further within 6 weeks. Ongoing deadline.

Angus Allnatt Charitable Foundation Fund

Aims/priorities: The Angus Allnatt Charitable Foundation offers funding to registered charities active in England, Scotland and Wales. The funding is intended to support charitable organisations that help young musicians aged 13-25, particularly those at the beginning of a professional career. The foundation helps fund workshops given by professional musicians in secondary schools.

Who can apply? Eligible organisations must be UK registered charities, operate in England, Scotland or Wales, support young people, aged 13 to 25.

Grant amount: Grants range from £500 to £3,000.

Application process: In writing and the deadline is ongoing but due to the volume of applications received, applicants are advised to submit a proposal, or give notice that they intend to do so, at least six months in advance.

CHILDREN, YOUNG PEOPLE & FAMILIES

Happy Days Children's Charity

Aims/priorities: The Happy Days Charity is a national children's charity dedicated to providing holidays, days out, and theatre trips for disadvantaged young people with special needs. The Charity supports families with children aged 3-17 who have learning difficulties, physical or mental disabilities, acute, chronic or life limiting illnesses, been abused or neglected, witnessed domestic violence, been bereaved or act as carers for a parent or a sibling.



Eligible applicants can apply for the costs of the following activities:

- Day trips and Visiting Theatre: funding for a day trip to a wide variety of destinations or for a theatre performance or experience.
Items that can be funded are tickets/passes and transport costs.
- Family Respite Breaks: support to meet the costs of a two to four nights UK respite break. However, under special circumstances, the choice of destination may be extended.
- Group Activity Holidays: group activity holiday to a wide variety of destinations.

Who can apply? Parents, carers, referral professionals, schools, groups (please see website for relevant applicants)

Warburton Families Matter Community Grants Programme

Aims/priorities: Warburtons offers small grants to support charitable organisations that require a small amount of money to help them deliver a broader activity. The aim of the small grants is to support projects, activities and organisations that will be of real direct benefit to families and have a direct and tangible social impact on people's lives.



Funding is available for projects that focus on supporting families that need the most help and are in line with the following social themes:

Plunkett Foundation – More than a Pub

Aims/priorities: Funded by Power to Change and delivered by Plunkett Foundation, the 'More than a Pub' programme has been relaunched with £2.2 million in funding to support communities in both rural and urban areas across England to help them save their local pub.



The programme offers a comprehensive package of business-development support, advice and loan and grant funding to assist community pub businesses consider their viability at all stages of their development.

The following funding options are available:

- Bursary awards of up to £2,500 (inclusive of VAT) to fund development costs at the pre-feasibility stage of the project, which could include consultation with the community, incorporation fees, valuation and survey fees, professional services, printing and marketing.
- Loan and grant combined funding package of up to £100,000 (the maximum grant contribution is £50,000 and loan and grant funding must be made up of equal amounts). Funding can be used for capital costs only.

Groups will also be able to access:

- Action planning support with an approved adviser outlining the keys steps involved in setting up a community pub business.
- Learning, events and peer networking with existing community pub businesses and sector specialists through visits, events and webinars.

Who can apply? In order to qualify for support through the More than a Pub programme, you must be based in England and: want to take ownership of a pub, want to open and run a community pub, be incorporated or intend to incorporate, have a charitable purpose, be for the

benefit of the public, address local needs, trade for the benefit of the community, run democratically, have local support and investors

Grant Amount: Bursary awards of up to £2,500, Loan and grant combined funding package of up to £100,000

Allen Lane Foundation

Aims/Priorities: For work that makes a difference to people's lives as opposed to simply alleviating the symptoms or current problems and should aim to reduce isolation,

stigma and discrimination. We fund seven particular beneficiary groups:



- Asylum seekers and refugees
- Gypsies and Travellers
- Migrant communities
- Offenders and ex-offenders
- Older people
- People experiencing mental health problems
- People experiencing violence or abuse

Who Can Apply: Grants are available for Small registered charities, voluntary groups and charitable organisations in the UK

Grant Amount: Maximum grant £15,000. The average grant is between £5,000 and £6,000. Grants repeated for more than one year vary from around £500 per annum up to £5,000 per annum, for a maximum of three years.

DEVELOPMENT

Quaker Housing Trust

Aims/priorities: The Quaker Housing Trust, a small registered charity, offers grants and interest-free loans for projects to provide housing for those in need in England, Scotland or Wales.



The Trust offers the following support for work relating to good practice and development:

- Health Check Service: provides a professional consultant to help evaluate the present and future 'health' and potential of the housing project.
- Feasibility Study Grant: towards the cost of getting professional to help test the feasibility of specific proposals for providing affordable rented housing.
- Environmental Assessment Grant: towards the cost of getting professional help to identify and use environmentally-friendly options in a social housing project.
- Dissemination of Good Practice: towards the cost of making more widely available proven good practice which will help other organisations provide better social housing.

Who can apply? Charitable organisations that are operating in Britain that meet all of the following criteria are eligible to apply:

- Have legal charitable status (registered with Charity Commission, OSCR and/or HMRC).
- Be a small organisation with limited funds available for the work they want to do - an annual turnover of up to £1 million and without access to sufficient income, reserves, nor other fundraising, to pay for the work they want to do.
- Be meeting a real and demonstrable housing need.
- Be providing actual 'bricks & mortar' housing.
- Be letting the homes at a realistic rent which low income occupants can genuinely afford.

Organisations do not need to have pre-existing Quaker links or support in order to apply for funding.

Grant amount: No minimum or maximum amount is specified.

Deadline: The next deadlines for application are: 16 August, and 18 October.

Move On Fund

Aims/priorities: The government is committed to halving the number of rough sleepers by 2022 and ending rough sleeping entirely by 2027. Whilst hostels and refuges provide a vital role in delivering temporary or emergency accommodation for rough sleepers, they are deemed unsuitable for longer-term housing. To meet this need, the Move On Fund has been established.

The Fund aims to free up hostel and refuge spaces by increasing the availability of affordable move-on, or second stage housing, for rough sleepers and those in hostel accommodation, and victims of domestic abuse currently living in refuges who are ready to leave this type of provision but might otherwise not be in a position to access the next stage of housing.

Capital grants are available towards the costs of developing move-on accommodation.
