Greater Manchester: ESF Community Grants 2019 – 2021

Aims/priorities: A £4.9 million programme to tackle unemployment has been launched with backing from the European Social Fund. The funds have been granted by the government's Education and Skills Funding Agency (ESFA) in partnership with Greater Manchester Local Enterprise Partnership to the WEA (Workers' Educational Association), an adult education charity which provides training and learning opportunities for people at risk of exclusion. Over the next two years, the charity will help thousands of people who face additional barriers in the workplace, such as lone parents, improve their employability and gain permanent employment.

The funding can help all who are out of work but especially those that:

- are homeless or at risk of being homeless
- have low or no qualifications
- lack literacy and numeracy skills
- are lone parents
- have disabilities, learning difficulties or health conditions
- are women
- are from ethnic minorities
- are aged over 50

Who can apply? Third sector organisation run on a not for profit basis, including:

- Constituted Voluntary / Community Group
- Social Enterprise (Not For Profit)
- Registered Charity
- Community Interest Company (CIC)
- Company Limited By Guarantee

Organisations need to employ no more than 20 full time equivalent staff AND have an annual turnover under £1,000,000

Grant amount: The WEA will distribute small grants of £20,000

Aims/priorities: First Choice Homes Oldham (FCHO) and partners have once again announced Rapid ROCA – a fantastic opportunity for local projects to receive a quick £500 cash boost!



In competition with others; the panel are looking for applications that 'Most benefit the community' Please note the panel are ideally looking to support new and emerging groups/initiatives that have previously not received ROCA funding.

You should have a clear idea of what you want to achieve and how are you going to do it. There must be evidence of a need for the project. Your project must be started within 4 months of applying for funding.

Who can apply: Voluntary and community groups with an annual income less than £20k based in Oldham. Applicants will ideally already have a committee of members and a bank account in place but start-up projects that don't will still be considered. Please note, Rapid ROCA will not fund any statutory organisations or political groups.

Our Rochdale Connect You

Aims/priorities: Applications must demonstrate how it will meet all 5 key criteria:



- Enabling – working with current or new community groups to quickly and easily support them
- Responding – to opportunities and gaps identified within communities
- Connecting – reaching and involving more community members as a result of the funding
- Targeting – specific groups such as, long term conditions, or areas agreed at neighbourhood level
- Building – adding value to your community through an essential 'trade' criteria where the receiving group are asked to offer a trade-off in a community contribution.

There are 5 priorities to bid against focused on fun, connecting people and ultimately improving lifestyles. These priorities have also been identified because they are centred on evidence based approaches which impact on the seed funding theme of improving wellbeing and reduce pressure on services:

- Arts and culture
- Walking and physical activity
- Growing and cooking

Tameside Community Wellbeing Investments

Aims/priorities: Supporting good ideas that meet the following Community Wellbeing Investment Priorities:

- Improve wellbeing, and health of people with long term health conditions.



- Reduce social isolation (lack of contact with people and society).
- Reduce loneliness (emotional response to a lack of connection or communication with people).
- Create mutually beneficial networks of support and resilience (including carers).
- Support people with low mood, low self-esteem / loss of confidence.
- Support place-based working that improves lives in local communities.

Who can apply? This investment is open to all local VCFSE groups that are members of Action Together CIO (becoming a member is simple, free and support is available to help you).

Grant amount: Groups can apply for different tiers of investment, up to £10,000 and between £10,000 and £25,000 by application, as well as larger awards for areas of support we identify and Participatory Budgeting opportunities later in the year. The investment monies available will be just over £1million over the next 2 years.

Aims/priorities: Near Neighbours brings people together from communities that are religiously and ethnically diverse, so that they can get to know each other better, build relationships of trust and collaborate together on initiatives that improve the local community they live in. #IWILL Fund 2019

Aims/priorities: To help young people have a say in how community spaces are managed. The #iwill Fund supports the aim of the #iwill campaign to make social action part of life for as many 10 to 20 year-olds as possible, forming a habit of community involvement they will continue as adults.



Community spaces are (or could be) open to members of the public. This might include places where young people interact with services and institutions, places that young people struggle to access or use in the way that they would like and/or where young people's voices aren't currently represented. Applications will be assessed against the following criteria: An approach that draws on young people's lived experience to improve community, Outcomes, Diversity and Inclusion and Organisational health.

Who can apply? Community organisations across England

Grant amount: Up to £35,000. The Fund is expected to make up to eight grants, available for one year. Successful applicants will have the opportunity to re-apply for up to two years' further funding, to build on their learning and focus on sustaining their impact.

Heart of the Community Fund

Aims/priorities: Virgin Money Foundation are on a mission to support community regeneration by backing people who can make big changes happen locally. Funds can be used to buy materials and equipment, make improvements to a community building or sports facility,



clean up an area of wasteland or support an event. The money could also pay for staff to run an activity.

Who can apply? Virgin Money Foundation love helping local communities thrive – and they'd love to see applications from community organisations working at the heart of Manchester. There is a voting unit in the Manchester Lounge and the awards will go to the community organisations with the most votes from Virgin Money customers and Lounge members. Virgin Money Foundation would love to support projects run by smaller local community organisations. That means annual running costs of less than £500,000. Organisations working in the parts of the City that need money the most, with strong local roots and benefiting the wider community are invited to apply.

Grant Amount: Every three months, Virgin Money Foundation give three local community organisations the chance to win £2,000 – with awards of £1,000 and £500 for the runners-up.

Transformation Foundation

Aims/priorities: The Transformation Foundations goals are simple: To provide the initial funding to small and mid-size charities to help them prove the potential of online marketing as a way of recruiting donors, volunteers, campaigners or

helping beneficiaries. The commercial sector spends 45% of budgets on online advertising versus charities that spend 2%. Funding for digital is hard to come by: many funders are not geared up for funding digital, so that is what Transformation Foundation do. Since 71% of online advertising is spent on Google and Facebook, the Transformation Foundation focus on these two platforms and the website as a key tool for content and conversions.

Who can apply? UK and Irish-registered organisations that are clearly for public benefit and the creation of social value. If you are not a registered charity but are a not-for-profit organisation, and so something which is clearly in the public good, we will still consider funding your organisation.

Grant amount: Facebook Grant programme – up to £5000. Website Grant Programme – covers upfront costs of a new charity specific website including strategy, design, development and training.

ENVIRONMENT

Polden-Puckham Charitable Foundation

Aims/priorities: Projects must contribute to the development of a just society based on a commitment to non-violence and environmental sustainability. The Foundation's priority is to address systemic threats by seeking to change policy and attitudes at a national or European level. The Foundation also supports organisations or projects that are not UK registered charities if they can indicate a UK registered charity that is able to receive funds on their behalf. **Previous projects supported include:**



- Conflicts Forum which received a grant of £24,000 over three years to promote understanding between the Western and Muslim worlds by challenging attitudes, values and ideologies that promote conflict.
- Airport Watch which received a grant of £15,000 over two years to educate UK policy-makers about the dangerously unsustainable growth and levels of air freight to the environment and communities, and the influences and interests that lie behind them.

Who can apply? Registered Charities. The Foundation also supports organisations or projects that are not UK registered charities if they can indicate a UK registered charity that is able to

receive funds on their behalf. Priority will be given to small, pioneering organisations with an income of between 10,000 and £500,000.

Grant amount: £5,000 - £20,000

FAITH

Jill Franklin Trust

Aims/priorities: The trust has five areas for which it is soliciting grant applications;

- Self-Help groups, advice, training, and employment; to support people with a mental illness or learning difficulties, and their carers (parents etc.),
- Organisations helping and supporting refugees and asylum-seekers coming to or in the UK,
- The restoration (not “improvement”) of churches of architectural importance (half a page in Pevsner’s Buildings). The church should be open to visitors every day,
- Local schemes to help prisoners to resettle, or to inhibit delinquency,
- Bereavement counselling.

Who can apply? As stated above.

Grant Amount: Typically £1000 for one to three years (except for church restoration which is normally £500).

Bright Ideas Fund

Aims/priorities: The Bright Ideas Fund supports new community business ideas through the start-up and planning stages with tailored business support, to the implementation stage.



Who can apply? To be eligible to apply for the Bright Ideas Fund, you must:

- Be setting up a community business.
- Be based in England
- Be an incorporated or unincorporated organisation, but not an individual
- Have been established for five years or less
- Have a charitable purpose
- Ensure your idea is for community benefit
- Share Power to Change's impact goals
- Make your community business accessible and inclusive

National Lottery Awards for All England

Aims/priorities: A quick and simple way to get small National Lottery grants. A good application should do at least one of these three things:



- bring people together and build strong relationships in and across communities,
- improve the places and spaces that matter to communities and
- enable more people to fulfil their potential by working to address issues at the earliest possible stage.

Who can apply? You can apply if your organisation is a: voluntary or community organisation, registered charity, constituted group or club, not-for-profit company or Community Interest Company, school (as long as your project benefits and involves the communities around the school), statutory body (including town, parish and community council).

Grant amount: £300 to £10,000

Reaching Communities England

Aims/priorities: Flexible funding for organisations in England who want to take action on the issues that matter to people and communities.



Who can apply? You can apply if you're a: voluntary and community organisation, registered charity or charitable incorporated organisation (CIO), group of organisations, as long as they are led by a voluntary and community organisation, school, statutory body (including *local authorities*, town, parish or community council) and not for profit company including companies limited by guarantee and Community Interest Companies with two or more directors.

Grant amount: Over £10,000 for up to five years

The Woodward Charitable Trust

Aims/priorities: The Woodward Charitable Trust primarily funds charitable organisations in the UK and can make grants for overseas projects usually via UK charities. Priority is given to projects that make good use of volunteers, encourage past and current users to participate, ensure that funds awarded are being well used and fall within the following areas:

- Children / young people who are isolated, at risk of exclusion or involved in antisocial behaviour.
- Prisoners and ex-offenders and prisoners' families.
- Disadvantaged women, covering refuges, domestic violence and parenting.
- Disability projects, including rehabilitation and training.
- Arts outreach work by local groups involving disadvantaged people.
- Projects that promote integration and community cohesion amongst minority groups, including refugees and travellers.

Who can apply? Small volunteer involving organisations in the UK.

Grant amount: Three types of grant are awarded following bi-annual meetings in February and October:

- Small grants of £100-£500
- Large grants over £5000 – these are usually given to charities known by the Trustees
- Preference is given to small to medium sized charities with an income of less than £300,000 where small grants can have more impact. Most grants made are for one-off projects although some grants fund salaries and running costs.

Who can apply? Grants are only available to not-for-profit organisations in the Granada region, including: Charities, Community groups, Voluntary organisations, and Sports groups.

HERITAGE

Transforming Places Through Heritage Programme – Project Development

Grants

Aims/priorities: Grants are available for charities and social enterprises in England to help fund development



costs of projects that will create alternative uses for redundant or underused, community-owned historic buildings in town centres. Projects must be located in England, in places that are or have the potential to be a hub for their community, providing services to a wide catchment population. They will typically include a variety of uses, including retail, and be recognised by local people as their town centre or high street. This includes:

- Distinct towns centres and high streets within large cities.
- Rural settlements that are notable centres within a district, providing services for a wide hinterland that includes smaller villages. (Small village high streets will not qualify.)

Eligible locations must already be the focus of a wider strategy or initiative - a place-based initiative - which aims to revitalise the high street or town centre and is likely to be led by the local authority, neighbourhood planning group or a community-led organisation, such as a civic society or community land trust. (This could include Future High Streets Fund, Heritage Action Zone or Neighbourhood Plan.)

Who can apply? Applications are accepted from any of the following non-profit organisations:

- Charitable Incorporated Organisations (CIOs or SCIOs).
- Charitable Companies Limited by Guarantee.
- Charitable Community Benefit Societies.
- Community Benefit Societies.
- Not-for-private-profit Companies Limited by Guarantee.
- Community Interest Companies (CICs) Limited by Guarantee.
- Co-operatives.
- Parish and Town Councils.

Grant amount: up to £1000,000 area available for up to 90% of the cost of work involved. There is an overall limit of £150,000 on the total funding available for developing any one project. Organisations can only apply to one grant category at any one time but may apply for further grants on completion of the funded work (subject to the overall limit).

Application process: The following application deadlines apply:

- For grants of up to £15,000 - by 5pm on the last day of each calendar month. Decisions will be communicated within eight weeks.
- For grants of more than £15,000:
- An online application form is available to complete on the AHF website. Applicants can also submit an initial enquiry form if they would like to check their project will fit the scope of the programme's funding or would like further advice.
- AHF strongly encourages applicants to discuss any potential application with the relevant Support Officer in their area before submitting an application.

The Yapp Charitable Trust

Aims/priorities: Yapp offer grants to registered charities with a total annual expenditure of less than £40, 000 who are undertaking work with one of the below priority groups;



- Elderly people
- Children and young people aged 5-25
- People with physical impairments, learning difficulties or mental health challenges
- Social welfare – people trying to overcome life-limiting problems of a social, rather than medical, origin (such as addiction, relationship difficulties, abuse, offending).
- Education and learning (with a particular interest in people who are educationally disadvantaged whether adult or children).

Who can apply? Yapp only offer grants to registered charities that have been formally established for a minimum of three years. Newly registered charities may apply but the organisation must have appointed a management committee and adopted a governing document at least 3 years ago.

Grant amount: No more than £9,000 over three years. Requesting more than £3000 per year will not increase your chances of being awarded the maximum grant.

Application process: Applications are available to download in Word or PDF format from the website.

Deadline: Ongoing. Trustees meet 3 times per year to consider applications and decision time can take up to 5 months from the date of submission.

The Football Foundation Facilities Fund

Aims/priorities: Grants for building or refurbishing grassroots facilities, such as changing pavilions and playing surfaces for community benefit, with money provided by Premier League, The FA and the Government (via Sport England) and delivered by the Foundation. This fund gives grants for projects that:



- Improve facilities for football and other sport in local communities
- Sustain or increase participation amongst children and adults, regardless of background, age or ability.
- Help children and adults to develop their physical, mental, social and moral capacities through regular participation in sport.

Who can apply? Applications welcomed from football clubs, professional clubs', community trusts, multi-sports clubs, local authorities, all educational establishments, registered charitable organisations, not for profit companies limited by guarantee, industrial and provident societies and unincorporated and not for profit organisations. All applications must have security of tenure either be freehold or leasehold. A minimum of 25 years' security of tenure is required by leasehold.

Grant amount: Maximum of £500, 000.

Application process: Online in the first instance
