Tameside Community Wellbeing Investments

Aims/priorities: Supporting good ideas that meet the following Community Wellbeing Investment Priorities:



- Improve wellbeing, and health of people with long term health conditions.
- Reduce social isolation (lack of contact with people and society).
- Reduce loneliness (emotional response to a lack of connection or communication with people).
- Create mutually beneficial networks of support and resilience (including carers).
- Support people with low mood, low self-esteem / loss of confidence.
- Support place-based working that improves lives in local communities.

Who can apply? This investment is open to all local VCFSE groups that are members of Action Together CIO (becoming a member is simple, free and support is available to help you).

Grant amount: Groups can apply for different tiers of investment, up to £10,000 and between £10,000 and £25,000 by application, as well as larger awards for areas of support we identify and Participatory Budgeting opportunities later in the year. The investment monies available will be just over £1million over the next 2 years.

Funded with Food - Funding Oldham's ideas, one plate at a time.

Aims/priorities: "Funded with Food" is a crowdfunding event with a difference, aimed at **local people with local ideas** and funded by the community itself.

Who can apply? Anyone with ideas that will change the community for the better.

Green Dividend Fund

Aims/priorities: The Green Dividend Fund is a fund to spark and support community action and initiatives. It aims to enable places in Oldham to be greener through innovative gardening, landscaping, and other environmental projects.



The fund aims to help deliver ideas and projects that make a real difference now, and in the future. These projects benefit streets and neighbourhoods for both residents and visitors.

Who can apply? Voluntary, Community and Social Enterprise (VCSE) organisation including small local community and voluntary groups, registered charities and social enterprises and co-operatives. If you are a group of residents who are not a VCSE organisation you can still apply for funding, but you will require the support of a local councillor who will act as a sponsor. The Council will administer funds on your behalf.
